Vista Index Services, LLC (“Vista Index”) respects the privacy rights of its users and is strongly committed to protecting your privacy. Please read this Privacy Policy carefully and in its entirety. It describes what information Vista Index collects that can identify you as an individual, directly or indirectly (“Personal Information”), when you visit or use the Vista Index website www.vistaindex.com (the “Site”) or request information from Vista Index, how Vista Index uses, shares and protects that Personal Information and the choices you have with respect to your Personal Information that Vista Index collects. By continuing to visit or use the Site, you accept the practices and policies outlined in this Privacy Policy, and you consent to Vista Index’s collection, use and sharing of your Personal Information in the manner described herein. If you do not agree with all of the provisions of this Privacy Policy, do not visit or use the Site.

Collection of Your Personal Information

Vista Index collects Personal Information from you that you voluntarily provide to Vista Index when you use the Site and when you contact Vista Index, which may include your name, address, e-mail address, password and other contact and account login information. For example, Vista Index collects Personal Information when you register to receive information from Vista Index and when you contact Vista Index to make product or support inquiries. Vista Index may also request Personal Information from you if you register for an account with Vista Index through the Site or request information.

If you are a representative of one of our paid subscribers, Vista Index may also collect your Personal Information such as your name, work title and contact details from the party you represent.

Use of Cookies And Other Electronic Tools

Vista Index may use various electronic tools, including “cookies”, to collect information and data that cannot be used to identify you personally (“Non-Personal Information”) when you visit or use the Site, including, for example,

information about your computer's IP address, browser type, language, operating system and the state from which you accessed the Site. A cookie is a small text file (up to 4KB) that is transferred to your computer's hard drive. Most desktop and mobile web browsers are set to accept cookies by default. You can usually set your browser to disable cookies, or to alert you when cookies are being sent. The help functions on most browsers and mobile devices contain instructions on how to set your browser to notify you before accepting cookies, disable cookies entirely, or disable the collection of certain data. If you disable cookies or refuse to accept a request to place a cookie, it is possible that some parts of the Site will not function properly.

Vista Index does not respond to "Do Not Track" requests at this time.

Use and Sharing of Your Personal Information

Vista Index uses your Personal Information to communicate with you and to provide you with your requested information or support. Vista Index may also provide you with information about Vista Index's products and services. You may instruct Vista Index not to use your Personal Information for this purpose by sending an email to Ops@vistacap.com or by clicking on the "Unsubscribe" link at the bottom of an email message from Vista Index with information about products and services.

Vista Index will not share your Personal Information with third parties without your consent, except that Vista Index may share your Personal Information:

- With Vista Index's affiliated companies;
- With contractors and other third parties Vista Index uses to provide and/or support the Site, including website hosting providers;
- To comply with the law or in response to a subpoena, court order or other legal process;
- To defend against legal claims and protect Vista Index's rights and property;
- To enforce Vista Index's Terms of Use for the Site; and

- In the event Vista Index participates in a substantial corporate transaction, such as a corporate restructuring, the purchase of another business, the sale of Vista Index's business or a merger or consolidation with a third party.

Vista Index may collect, analyse and share Non-Personal Information (including Personal Information that has been aggregated and anonymized so that it can no longer identify you individually) from your visits to and use of the Site to identify trends and statistics that may help improve the Site, Vista Index's products and customer service and for any other purposes that Vista Index may deem appropriate.

Security of Your Personal Information

Vista Index uses reasonable administrative, technical, personnel, and physical measures to safeguard your Personal Information against loss, theft, unauthorized use, disclosure, or modification. In particular:

- Vista Index's third party website hosting provider, currently WP Engine, stores your Personal Information on its remote servers, which are isolated and accessible only to WP Engine and Vista Index. To learn about the security measures provided by WP Engine, click [here](#).
- Vista Index enforces password strength rules for accounts through the Site and uses 2-factor authentication to enhance the security of your login ID.
- Vista Index uses Secure Sockets Layer (SSL) encryption technology and end-to-end encryption that ensures your Personal Information is encrypted before it is sent over the internet.

To help protect your privacy, you should maintain the secrecy of the login ID and password you may have in connection with your use of the Site.

Please note that no information security practices are 100% secure or immune from circumvention. Vista Index cannot give you an absolute guarantee that your Personal Information will always be secure. If Vista Index learns of a security breach that jeopardizes or may jeopardize the security and confidentiality of your Personal Information, Vista Index will attempt to notify

you electronically (subject to any applicable laws) at the email address you have provided through the Site.
